2024 Membership Fees

Fees collected from vendors for participation in the 2024 Rushford Peterson Valley Farmers' Market will be used for necessary insurance, promotional needs, and other market events and expenses. The 2024 season will run from May 21st until October 1st. A full season covers <u>all</u> weeks and a half season covers the first or last 10 weeks of the market season. Fees must be paid prior to the first market day. The market will run on Tuesdays from 3:30pm – 6:00pm.

Sampler Membership for First Time Vendor

New vendors wishing to sample our market must fill out the application, be approved by the market manager, and pay a \$10 participation fee per market day. This sampling is available for a maximum of two market days. If you decide to continue with a 2024 membership, your sampling fees will be deducted from your seasonal membership fee. If you have participated in the market in the past, you are not eligible for this program.
